### Neocolonialism


Neocolonialism is an advancement of capitalism where capitalist nations dominate their subjects.

African nations have become profound elements of neocolonialism subjects to international powers.

Originally, it was a policy to sustain regulation of African nations.

Usually, the concept is broadened by nations with direct means to Africa.

The United States is deemed to have the dominant power over Africa.

The understanding that western products are much superior.


Also, the African cultures and ideas are inferior to Europeans.

### FACTORS INFLUENCING NEOCOLONIALISM






# Impact of Neocolonialism

#### Issues Surrounding Neocolonialism

- Kwame Nkrumah nailed that while many African nations have attained independence and acquired total regulation of their resources and affairs, they still further from indirect control from outside.
- Most African colonies are included in the European integration projects.
- African countries have managed to establish colonial treaties with Europeans that heighten their dependency.
- China has already established treaties that enslave Africans and those in Diaspora both on resources and management.

 Some have come in as Donors and Aid organizations with underlying intentions.




# Response to Neocolonialism
